





Consequences of directives

- Risk of costly policy mistakes
 - No public consultation needed, not transparent
 - No rationale or cost-benefit analysis required
 - Expert agency advice can be ignored
- Policy surprises and instability
 - No notice required
 - Policy exposed to short-term political pressures and ministerial rotation
 - Fixes needed when mistakes become apparent



Governance reforms

- O 'Down-size' the Ministry of Energy
 - Move all staff to OPA, OEB or IESO
- Remove ministerial directive authority
- Strengthen agency appointment processes
- Specify major energy policy objectives in legislation (e.g. long term energy supply mix)

Benefits of governance reform

- Improved policy consistency and predictability
- Increased investor confidence
- Lower cost of capital -> lower consumer rates
- More investment in infrastructure, improved reliability
